Spec 4.3.5 under Subsection - Bathroom Walls states that, "Vendor must supply and install matching trim to cover any unfinished or rough surfaces."

Vendor Question No. 3:

Are the existing bathroom fans being replaced?

Agency Response:

Cabin 1 is the only cabin with an existing bathroom fan that will be replaced. In all other cabins, the bathroom fan will be a new install. Spec 4.8.3 under Subsection – Bathroom Lighting states, "the vendor must supply and install Broan 100 CFM Ceiling Bathroom Exhaust Bath Fan with Light in ceiling or equal."

Vendor Question No. 4:

I am requesting an 8-day extension for submitting questions from 10/31/2018 to 11/07/2018 (11/06/2018 is a State holiday) and a 5-day extension of the bid opening date from 11/16/2018 to 11/21/2018 for all 5 groups of cabins for this project.
