RESPONSE TO VENDOR QUESTIONS

Vendor Question No. 1:

Do contractors need to do testing for lead paint or asbestos in cabins to be included in the bid price?

Agency Response: There is no requirement for the owner to test for lead paint. The contractor should assume that any paint or varnish encountered contains lead unless he determines otherwise.

The owner believes that the transite panels inside the classic cabin furnace closets are asbestos containing materials. The owner does not believe that they need to be disturbed. The Contractor is instructed to not disturb the transite panel.

The contractor should take all precautions necessary to protect his employees to hazardous materials.

Vendor Question No. 2:

What is the official start date to begin the work?

Agency Response: Official start date is immediately upon Notice to Proceed as stated in General Terms and Conditions, Item #4.

Vendor Question No. 3:

During the process do the contractors receive a list of all other contractors who are bidding on the project that they are competing with in bids?

Agency Response: No

Vendor Question No. 4:

If there is a weather event during the work timeframe such as a blizzard, does that extend the 180 days that the work is to be completed within / without the daily penalty?
