APPLICATION INFORMATION

1. WV Residents only may apply for a permit to participate in the GBO Controlled Hunt, either individually or as part of a group, at the Observatory's Green Bank, WV site. **Follow the instructions on the accompanying application exactly.**
2. Applications must be signed, legible and complete, and received by GBO by August 1, 2017. An individual's name may appear on only one application. Violation of these conditions will disqualify the applicant. Permits will be assigned by random selection, by computer, for each date of the hunt and weapon of choice. The applicant may request to be placed in the lottery for either one or both days of the hunt. Lottery winners may get either one or both of the days requested. Lottery winners should receive notification of their selected hunt day(s) by the last week of August.
3. The hunt will take place on Oct. 13 & 14 for bows, muzzleloaders and shotguns w/slugs. The lottery will determine which days each hunter will actually be eligible to hunt. **PLEASE NOTE: Walk-ins will NOT be allowed to hunt the GBO property.**
4. All hunting regulations of the West Virginia Division of Natural Resources will apply to this hunt. However, **the deer taken during this hunt are BONUS deer and will NOT be counted against the hunter's licensed bag limit.** Additionally, it should be noted by the prospective applicant that any deer taken during this hunt must be antlerless deer, except that each day of the hunt an on-site lottery will be held which will allow five (5) hunters to hunt an either sex deer.
5. There are a limited number of handicapped areas available. If you are handicapped (paraplegic or quadriplegic), please indicate this on your application.
6. All applicants on the same application must choose the same weapon type, i.e. you may choose only one of Bow, Muzzleloader, or Shotgun w/slugs as the **Weapon To Be Used.**
7. The site will have designated areas for specific weapons' use. GBO Rules and Regulations will be provided to each successful applicant prior to each day's hunt. **These Rules and Regulations will be strictly enforced. Any violation of the GBO Rules and Regulations will be cause for expulsion from the property and elimination from the remainder of the hunt and future hunts.**
8. Two-way radios are prohibited from use on the GBO site, therefore **NO** two-way radios are allowed during this hunt.
