1. What is the manufacture and color of the shingle required for these roofs?

A: IKO Armourshake, Color: "Shadow Black", or approved equivalent.

2. There are two built-in gutters on the front of the gift shop building. Can we remove and installed sheathing in gutter area? Install the new gutters on eaves?

A: The existing gutters on the front of the building must be removed and replaced in their current location.

3. Are we to remove and replace all existing gutters and downspouts on the gift shop?

A: The existing gutters on the front of the building will be removed and replaced back in their current location. The remainder of the gutters will be removed and replaced with like gutters and tied into the existing downspouts.

4. The gift shop has a brick chimney thru the roof and has deteriorated. Should we remove completely to below roof and install metal vent if needed? Should we tear down to below roof, seal off vent, and install sheathing to allow shingle over?

A: The chimney will remain in place and be properly sealed/caulked/flashed.

5. What are we to do at ridge area on gift shop? Are we to install a shingle over vent? Or are we to install just shingles as they are existing?

A: Install a ridge vent compatible with the shingle warranty.

6. There is a small flat roof on the back of the gift shop building that is shingled. Are we to install new lumber joists and roof deck to create a 4/12 pitched roof and then flash and shingle?

A: No. Park personnel will address any necessary work/shingling on this attachment.

7. If the shingles are a quarter inch thick, the valleys cannot be lapped. So, are we to install valley metal in all valleys? And what gauge?

A: Yes, 28-guage minimum, and per manufacture's installation recommendations.


