3.4.10.1 Front safety railing has middle/center removable section with hitch pin fastener for easy conversion to an open bow.

3.4.11 Has installed two (2) pivoting electrofishing booms with chain supports.

3.4.11.1 Has high and low boom supports on side of rear shock rail uprights for transport.

3.4.11.2 Has three (3) collapsible anode droppers (one as a spare).

3.4.12 Has LED navigation lights.

3.4.13 Has installed adjustable LED headlights

3.4.13.1 Do not interfere with removable/hinged bow railing section.

3.4.13.2 Do not interfere with gill netting operations (i.e. must not be located in a position where gill nets set from the front can get tangled on).

3.4.14 Has installed LED electrofishing lights

3.4.14.1 Do not interfere with gill netting operations (i.e. not located in a position where gill nets set from the front can get tangled on).

3.4.14.2 LED lights are adjustable to illuminate bow front, bow sides, rear and rear sides.

3.4.15 Has red LED deck lights.

3.4.16 Minimum of two 12-volt DC accessory waterproof plugs.

3.4.17 Has easily accessible on-board automatic battery charging system.

3.4.17.1 Batteries charged by either motor and/or plugged in charger to generator.

3.4.18 Has independent starting batteries for motors with boxes/trays and strap downs. Generator has independent internal battery

3.4.19 Has automatic bilge pump that can also be operated manually with 800gph

3.4.20 Has a horn.

3.4.21 Has a console mounted LED work light to illuminate the working area around the livewell.

3.4.22 Has a shallow water anchor (power pole).

3.4.23 Has gunwale storage at rear and at least one (1) side for gear/equipment that is water resistant and secured with latches.

3.4.24 Has approx. 25-30 gallon aluminum EPA compliant fuel tank, mounted under bow deck with fill line protected from water and will not interfere with deck work.

3.4.24.1 Fuel line lines run to back of boat in a concealed/protected housing.

3.4.25 Has installed fire extinguisher.

3.4.26 All wiring is concealed and waterproof.

3.4.27 Has installed wash down pump and spray hose with filtered intake and quick connects for attachment and removal for storage after use.

3.4.27.1 Pump is easily accessible for maintenance.

3.4.28 Hose is long enough to reach front bow deck of boat.

3.4.29 Large river boat is compatible with Item 3.1, 3.2 and 3.5.

3.5 Boat Trailer Current Year Model, New

3.5.1 Trailers are compatible with Items 3.3 and 3.4 while Items 3.1 and 3.2 are loaded.

3.5.2 Aluminum I-beam.

3.5.3 Tandem axle.

- 3.5.4 Hydraulic surge disc brakes on one axle.
- 3.5.5 2-inch coupler.
- 3.5.6 Waterproof LED lights.
- 3.5.7 Heavy-duty winch and safety chain.
- 3.5.8 Mounted spare tire.
- 3.5.9 Transom-mounted straps.
- 3.5.10 Has minimum 36" guide bunks on sides
- 3.5.11 Has side slick bunks that are composite and low friction slides.
- 3.5.11.1 Bottom roller bunks for Item 3.4.
- 3.5.12 Metal fenders with treadplate
- 3.5.12.1 Must be strong enough to support a minimum 250-pound person.
- 3.5.13 Has 15" wheels.
- 3.5.14 Trailer tires 10-ply.
